<b>Lodgement period</b>	<p>Nil, however this form is to be lodged with an office copy of the court order, in the time set down for the lodgement of the court order.</p> <p>A form is not considered lodged until it is received and accepted by ASIC as complying with s1274(8) of the <i>Corporations Act 2001</i>. A receipt will not be issued unless requested.</p>
<b>Lodgement fee</b>	<p>Nil, however late fees may be payable on the court order.</p> <p>The late fees are:</p> <ul style="list-style-type: none"><li>• \$65 for up to one month late</li><li>• \$270 for over one month late.</li></ul>
<b>Office copy of a court order</b>	An office copy of a court order must bear an originally stamped seal of the registry of the court.
<b>Completing this form</b>	Please ensure that the tick boxes are completed to show the correct type of court order applied for and that a separate cover page, Form 105, is used for each court order.
